- 1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district, to which they have been allocated.
- 2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of their court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer.

Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website also.

- 3. Principal District & Sessions Judge, North shall withdraw sufficient number of cases from the existing court of District Judge (Commercial Court) and shall assign the same to the newly constituted court i.e. District Judge (Commercial Court)-02, North District and shall ensure that after redistribution, both the courts shall have substantially equal work. In view of the creation of new court, the existing court of District Judge (Commercial Court) previously presided over by Sh. Gorakh Nath Pandey is re-designated as District Judge (Commercial Court)-01, North District.
- 4. That Principal District & Session Judge, New Delhi shall withdraw sufficient number of cases from the existing courts of District Judge-01 to District Judge-04, New Delhi District and shall assign the same to the newly constituted court of District Judge-05, New Delhi District and shall ensure that after re-distribution, all the courts shall have substantially equal work to enable the courts to dispose of old matters expeditiously.
- 5. That Principal District & Session Judge/HQs. shall withdraw sufficient number of cases from the existing courts of District Judge-01 to District Judge-12, Central and shall assign the same to the newly constituted court of District Judge-13, Central to ensure that after redistribution, all the courts shall have substantially equal work to enable the courts to dispose of old matters expeditiously.

Railway Station and RPF from the court of JMFC-07, Central and shall assign the same to the newly created court of JMFC-11, Central, THC which shall ensure its expeditious disposal in accordance with law.

Principal District and Sessions Judge (HQ) shall withdraw sufficient number of cases from JMFC(NI Act) Digital Court-01 to JMFC(NI Act) Digital Court-03 of Central District and shall assign the same to the newly constituted court of JMFC(NI Act) Digital Court-04, Central in such a manner that after redistribution, all courts should have substantially equal number of cases.
- 14. The newly created court of JMFC (Digital Traffic Court) at North and North-West District shall also deal with the NBT and Spot challans on virtual traffic court portal of their respective district along with the challans which are contested on Virtual Traffic Court Portal. All the pending challans of NBT and SPOT pertaining to the above district on Virtual Traffic Court Portal shall be transferred from the existing Virtual Traffic Courts i.e. JMFC (Virtual Traffic Court)-01, JMFC (Virtual Traffic Court)-03 to the above courts immediately. Consequently, the work of the existing Virtual Traffic Court)-01, JMFC (Virtual Traffic Court)-01, JMFC (Virtual Traffic Court)-03 of Central District shall also be looked after by the above newly created Digital Traffic Courts. Mr. Sunil

- Khatri, JMFC (Virtual Traffic Court)-02, Central shall report to the Principal District and Sessions Judge (HQ) till further orders.
- 15. Principal District and Sessions Judge, West shall withdraw all traffic challans, e-traffic challans, STA challans and MCD challans pending in the court of JMFC-01, JMFC-03, JMFC-04, JMFC-05, JMFC-06 and JMFC-08 of West District and shall assign the same to the newly created court of JMFC-09, West which shall ensure that all the challans be dealt with expeditiously in accordance with law.
- 16. Ms. Shakshi Jaiswal shall report to the concerned Principal District and Sessions Judge, Shahdara on joining her duty, who shall inform this court immediately for further posting.
- 17. Principal District and Sessions Judge (HQ) shall withdraw all traffic challans, e-traffic challans, STA challans and MCD challans pending in the court of JMFC-02, JMFC-04, JMFC-05 and JMFC-07 of Central District and shall assign the same to the newly created court of JMFC-10, Central which shall ensure that all the challans be dealt with expeditiously in accordance with law. Further Principal District and Sessions Judge (HQ) shall withdraw the work relating to the police station Prashad Nagar and Mukherjee Nagar from the court of JMFC-01 and shall assign the same to the court of JMFC-02, Central.
- 18. Principal District and Sessions Judge, **South-West, Dwarka** shall withdraw all traffic challans, e-traffic challans and STA challans pending in the courts of JMFC-01 to JMFC-07 and JMFC-09 to JMFC-11 and shall assign the same to the existing Digital Traffic Court which shall ensure that all the challans shall be dealt with expeditiously in accordance with law.
- 19. Vide order dated 08.01.2024, additional work of Digital Traffic Court and Virtual Traffic Court of New Delhi was assigned to the court of JMFC (NI Act), Digital Court-03 presided over by Ms. Nishtha Mehtani. Principal District and Sessions Judge, New Delhi shall withdraw the above said additional work from her court and shall assign the same to the court of Ms. Vidushi Garg, who shall now deal with work of JMFC(Digital Traffic Court) as well as Virtual Traffic Court of New Delhi District.
- 20. Principal District and Sessions Judge, **Shahdara**, **KKD** shall withdraw all matters under NI Act pending in the court of CJM, ACJM, JMFC-01 to JMFC-06 and JMFC (Mahila Court)-02 of Shahdara District and shall assign the same to the newly created court of **JMFC** (NI Act), Shahdara, KKD for its expeditious disposal in accordance with law.
- 21. Principal District and Sessions Judge, **Shahdara**, **KKD** shall withdraw all traffic challans and STA challans pending in the court of JMFC-01, JMFC-03 & JMFC-06 of Shahdara District and shall also withdraw the work relating to PS Jyoti Nagar from the court of CJM and assign the same to the newly constituted court i.e. **JMFC-08**, **Shahdara**, **KKD**.
- 22. Principal District and Sessions Judge, East, KKD shall withdraw all traffic challans, etraffic challans, STA challans and MCD challans pending in the court of JMFC-01 to JMFC-05 of East, KKD and shall assign the same to newly created court of JMFC-06, East, KKD which shall ensure that all the challans shall be dealt with expeditiously in accordance with law.
- 23. All Relieving JMFC/Civil Judges shall perform all judicial works except deciding the cases finally. However, if they are deputed in a court where the officer is on long leave i.e. beyond one month, in such cases, the Relieving JMFC/Civil Judge shall also be empowered to decide the cases finally. All learned Principal District and Sessions Judges

shall keep record of the work done by the Relieving JMFC/Civil Judges posted in their respective districts and shall forward the same to the High Court on quarterly basis or till they get regular posting whichever is earlier.

- 24. Principal District & Sessions Judge, West shall withdraw sufficient number of cases from the existing JMFC (Mahila Court)-01 to JMFC (Mahila Court)-05, West, THC and shall assign the same to the newly created court of JMFC (Mahila Court)-06 in such a manner that after redistribution, all courts should have substantially equal work.
- 25. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of their court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website also.
