MEMORANDUM

The Disciplinary Authority proposes to hold an inquiry against Dr. G Ramgopal Naik, IPS (AGMUT: 2017) under Rule 8 of the All India Services (Discipline and Appeal) Rules, 1969. The substance of the imputations of misconduct or misbehavior in respect of which the inquiry is proposed to be held is set out in the enclosed statement of Articles of Charge (Annexure-I). A statement of the imputations of misconduct or misbehavior in support of each Article of Charge is enclosed (Annexure-II). A list of documents by which the articles of charge are proposed to be sustained are also enclosed (Annexure III).

- 2. Dr. G Ramgopal Naik, IPS (AGMUT: 2017) is directed to submit a written statement of his defense within 30 days of receipt of this memorandum and also to state whether he desires to heard in person.
- **3.** Dr. G Ramgopal Naik, IPS (AGMUT: 2017) is also informed that an inquiry will be held only in respect of those articles of charge that are not admitted. He should, therefore, specifically admit or deny each article of charge.
- 4. Dr. G Ramgopal Naik, IPS (AGMUT: 2017) is further informed that if he does not submit his written statement of defense on or before the date specified in para 2 above, or he does not appear in person before the Inquiring Authority or otherwise fails or refuses to comply with the provisions of Rule 8 of the All India Services (Discipline and Appeal) Rules, 1969 or the orders/instructions issued in pursuance of the said rule, the Inquiring Authority may hold the inquiry against him ex-parte.
- 5. Attention of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) is invited to Rule 18 of the All India Services (Conduct) Rules, 1968 under which no Government servant shall bring or attempt to bring any political or external influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter deals with in these proceedings, it will be presumed that Dr. G Ramgopal Naik, IPS (AGMUT: 2017) is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of Rule 18 of the All India Services (Conduct) Rules, 1968.

STATEMENT OF ARTICLES OF CHARGE AGAINST DR. G RAMGOPAL NAIK, IPS (AGMUT: 2017)

Article-I

Dr. G Ramgopal Naik, IPS (AGMUT: 2017) has willfully and persistently disobeyed the Ministry of Home Affairs' Order No. 15041/02/2024-UTS.I dated 13.12.2024, vide which he was transferred from Delhi to Arunachal Pradesh, and has failed to report to the Govt. of Arunachal Pradesh till date despite being relieved from the Delhi Police on 03.01.2025.

The above act of gross misconduct on the part of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) constitute a clear and severe failure to uphold the fundamental tenets of public service, specifically devotion to duty, maintenance of discipline, and implementation of lawful directives. His conduct is, thus, deemed to be unbecoming of a Government servant and in direct violation of the All India Services (Conduct) Rules, 1968, specifically Rule 3(1), Rule 3(2B)(xii), and Rule 3(2B)(xiii).

Article II

Dr. G Ramgopal Naik, IPS (AGMUT: 2017), in contravention of his official obligations and professional decorum, has remained absent from duty for a continuous period of more than seven months without providing any cogent justification and medical certification for his absence from service.

The above act of gross misconduct on the part of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) constitute a clear and severe failure to uphold the fundamental tenets of public service, specifically maintenance of absolute integrity and devotion to duty, maintenance of high ethical standards, accountability, and transparency, maintenance of discipline in the discharge of duties, and performance of duties with the highest degree of professionalism and dedication. His conduct is, thus, deemed to be unbecoming of a Government servant and in direct violation of the All India Services (Conduct) Rules, 1968, specifically Rule 3(1), Rule 3(1A)(i), Rule 3(1A)(i), Rule 3(2B)(xii), and Rule 3(2B)(xiii).



STATEMENT OF IMPUTATIONS OF MISCONDUCT OR MISBEHAVIOUR IN SUPPORT OF THE ARTICLES OF CHARGE AGAINST DR. G RAMGOPAL NAIK, IPS (AGMUT: 2017)

- I. Pursuant to induction to IPS from DANIPS vide MHA's notification dated 12.12.2024, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) was transferred from Delhi to Arunachal Pradesh vide the Ministry of Home Affairs' Order No. 15041/02/2024-UTS.I dated 13.12.2024, in terms of Para 8(vi)(b) of the Guidelines for Transfer/Posting of IAS/IPS officers of AGMUT Cadre, 2016.
- II. The Delhi Police, vide letter No. 60219/CB-I/PHQ dated 20.12.2024, forwarded a representation submitted by Dr. G Ramgopal Naik, IPS (AGMUT: 2017) for cancellation of his transfer order or for keeping the transfer order in abeyance. The representation was examined in this Ministry and found to be devoid of merit; accordingly, the same was rejected by the Competent Authority. Thereafter, MHA, vide letter dated 30.12.2024, informed the Delhi Police that the representation of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) had been rejected by the Competent Authority and also requested the Delhi Police to relieve the officer with immediate effect. Consequently, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) was relieved from the Delhi Police on 03.01.2025 with directions to report to his new segment of posting i.e., Arunachal Pradesh.
- LII. Para 9(viii) of the Guidelines for Transfer/Posting of IAS/IPS officers of AGMUT Cadre, 2016 stipulates that officers under transfer shall be relieved to join their new segment within 15 days from the effective date of transfer. Should non-compliance of transfer orders persist, the officer would be liable to incur several consequences under the service rules, such as stoppage of salary, issuance of displeasure, debarment from promotion/Central Deputation etc. The onus of joining a segment will lie on the officer.
- **IV.** The Govt. of Arunachal Pradesh informed this Ministry, vide letter dated 02.04.2025, that Dr. G Ramgopal Naik, IPS (AGMUT: 2017) had failed to report for duty in the Govt. of Arunachal Pradesh; moreover, his whereabouts were unknown and his mobile number was found to be switched off.
- V. The Ministry of Home Affairs, vide speaking order No. 15041/02/2024-UTS.I dated 15.04.2025, directed Dr. G Ramgopal Naik, IPS (AGMUT: 2017) to report to the Govt. of Arunachal Pradesh with immediate effect and, should non-compliance of the transfer order persist on his part, the officer would be liable to incur various consequences under the service rules, including disciplinary action, debarment from promotion etc. It was specifically conveyed to Dr. G Ramgopal Naik, IPS (AGMUT: 2017) that all his representations for cancellation of his transfer order or for keeping the order in abeyance had been rejected by the Competent Authority.
- VI. Dr. G Ramgopal Naik, IPS (AGMUT: 2017) informed the Govt. of Arunachal Pradesh, vide letter dated 17.04.2025, that he was unwell and under medical rest;

hence, he would report to the Govt. of Arunachal Pradesh only after he recovers from his ailments and is declared medically fit. Thereafter, the Ministry of Home Affairs, vide letter dated 23.05.2025, directed Dr. G Ramgopal Naik, IPS (AGMUT: 2017) to submit his medical records indicating the specific nature of his illness, prognosis of the said illness, and approximate period of recover, duly certified by the appropriate Medical Authority, to this Ministry within 01 week. However, the officer failed to furnish his medical records within the stipulated time-limit.

VII. The Ministry of Home Affairs, vide memorandum No. 15041/02/2024-UTS.I dated 03.07.2025, directed Dr. G Ramgopal Naik, IPS (AGMUT: 2017) to show cause as to why disciplinary proceedings should not be initiated against him for willful disobedience of transfer orders and for failing to report to the Govt. of Arunachal Pradesh even after the expiry of more than 07 months from issuance of transfer order.

VIII. In response, Dr. G Ramgopal Naik, IPS (AGMUT: 2017), vide letter dated 02.08.2025, claimed that he was on medical rest till 05.08.2025 and that he would report to the Govt. of Arunachal Pradesh after availing joining time of 14 days starting from 06.08.2025. However, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) again failed to submit any medical report to substantiate his claim of being unfit for duty for a period exceeding seven months. Moreover, Dr. G Ramgopal Naik, IPS (AGMUT: 2017), vide letter dated 19.08.2025, informed the Govt. of Arunachal Pradesh that he would be joining his duty on 01.09.2025 and would submit medical rest/fitness certificate only after joining his duty on 01.09.2025.

IX. The O/o the Director General of Police, vide letter 02.09.2025, has intimated that Dr. G Ramgopal Naik, IPS (AGMUT: 2017) has failed to report to the Govt. of Arunachal Pradesh on 01.09.2025 and has instead submitted an unsigned letter, without any supporting documents, stating that he is suffering from typhoid and that he will join the Govt. of Arunachal Pradesh only after recovering from his illness.

X. By the aforesaid chronology of events, it is clear that Dr. G Ramgopal Naik, IPS (AGMUT: 2017) has failed to report to the Govt. of Arunachal Pradesh even after the expiry of more than 08 months from issuance of transfer order dated 13.12.2024 and more than 07 months after being relieved from the Delhi Police. The officer has claimed to be under medical rest during the intervening period; however, he has neither submitted any medical document to substantiate his claim of being unfit to report to the Govt. of Arunachal Pradesh nor has he clarified the nature or prognosis of his illness till date.

The aforesaid acts of willful disobedience of orders, willful insubordination, grave dereliction of duty, gross indiscipline and prolonged absence from duty without any cogent reasons constitute gross misconduct which renders Dr. G Ramgopal Naik, IPS (AGMUT: 2017) liable for disciplinary action under the All India Services (Discipline and Appeal) Rules, 1969.

WHEREAS, the Ministry of Home Affairs, vide order of even number dated 13.12.2024, had ordered the transfer of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) from Delhi to Arunachal Pradesh within the AGMUT Cadre.

AND WHEREAS, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) has submitted another representation dated 24.03.2025 requesting this Ministry to re-examine and re-consider his representation for cancellation of transfer from Delhi to Arunachal Pradesh in light of his children's educational requirements. Should non-compliance of transfer orders persist, the officer would be liable to incur several consequences under the service rules, such as stoppage of salary, issuance of displeasure, debarment from promotion/Central Deputation etc. The onus of joining a segment will lie on the officer. Further, para 10(iv) of these Guidelines stipulates that transfer orders once issued will be strictly

enforced, and disciplinary proceedings would be initiated against officers who bring extraneous pressure for cancellation of transfer orders.

- 8. AND WHEREAS, the previous representation submitted by Dr. G Ramgopal Naik, IPS (AGMUT: 2017) for retention in Delhi was examined in this Ministry and disposed of with the approval of the Competent Authority. It is reiterated that the transfer order dated 13.12.2024 was issued on administrative grounds, and Dr. G Ramgopal Naik, IPS (AGMUT: 2017) was posted outside the segment from which he was inducted in terms of the guidelines in Para 8(vi)(b) of the Guidelines for Transfer/Posting of IAS/IPS officers of AGMUT cadre, 2016. The larger public interest arising out of the functional requirements of the Govt. of Arunachal Pradesh necessitates the joining of the aforesaid officer in that segment.
- 9. AND NOW THEREFORE, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) is directed to report to the Govt, of Arunachal Pradesh immediately without any further delay. Should non-compliance of the transfer order persist, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) would be liable to incur consequences under the service rules, including disciplinary action, debarment from promotion etc. In case of any further leave requirement owing to personal hardships, the same may be applied for in writing to the Competent Anthority in the Govt, of Arunachal Pradesh. Accordingly, all the representations submitted by Dr. G Ramgopal Naik, IPS (AGMUT: 2017) till date, are hereby rejected and disposed of No further representation shall be considered.

However, you have neither submitted any document to substantiate your claim of being medically unfit nor clarified the nature of illness that has rendered you unfit for service for approx. 05 months.

Accordingly, you are directed to submit your medical records indicating therewith the specific nature of your illness, prognosis of the said illness, and approximate period of recovery, duly certified by the appropriate medical authority specified in the All India Services (Medical Attendance) Rules, 1954, to this Ministry within 01 week of receipt of this letter.



MEMORANDUM

Subject: Initiation of disciplinary proceedings against Dr. G Ramgopal Naik, IPS (AGMUT: 2017) - reg.

WHEREAS, the Ministry of Home Affairs, vide order of even number dated 13.12.2024, had ordered the transfer of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) from Delhi to Arunachal Pradesh within the AGMUT Cadre.

- 2. AND WHEREAS, the Delhi Police, vide letter No. 60219/CB-I/PHQ dated 20.12.2024, forwarded the representation submitted by Dr. G Ramgopal Naik, IPS (AGMUT: 2017) for cancellation of his transfer order or for keeping the said transfer order in abeyance owing to the educational requirements of his children. The representation of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) was examined in this Ministry and found to be devoid of merit; accordingly, the same was rejected by the Competent Authority. Thereafter, MHA, vide letter dated 30.12.2024, informed the Delhi Police that the representation of Dr. G Ramgopal Naik, IPS (AGMUT: 2017) had been rejected by the Competent Authority and also requested the Delhi Police to relieve the officer with immediate effect.
- 3. AND WHEREAS, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) was relieved from the Delhi Police on 03.01.2025 with directions to report to his new segment of posting i.e., Arunachal Pradesh.
- 4. AND WHEREAS, the Govt. of Arunachal Pradesh informed this Ministry, vide letter dated 02.04.2025, that Dr. G Ramgopal Naik, IPS (AGMUT: 2017) had failed to report for duty in the Govt. of Arunachal Pradesh; moreover, his whereabouts were unknown and his mobile number was found to be switched off.
- 5. AND WHEREAS, MHA, vide speaking order dated 15.04.2025, directed Dr. G Ramgopal Naik, IPS (AGMUT: 2017) to report to the Govt. of Arunachal Pradesh with immediate effect and, should non-compliance of the transfer order persist on his part, the officer would be liable to incur various consequences under the service rules, including disciplinary action, debarment from promotion etc. It was specifically conveyed to Dr. G Ramgopal Naik, IPS (AGMUT: 2017) that all his representations for cancellation of his transfer order or for keeping the order in abeyance had been rejected by the Competent Authority.

- 6. AND WHEREAS, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) informed the Govt. of Arunachal Pradesh, vide letter dated 17.04.2025, that he was unwell and under medical rest; hence, he would report to the Govt. of Arunachal Pradesh only after he recovers from his ailments and is declared medically fit. Accordingly, MHA, vide letter dated 23.05.2025, directed Dr. G Ramgopal Naik, IPS (AGMUT: 2017) to submit his medical records indicating the specific nature of his illness, prognosis of the said illness, and approximate period of recover, duly certified by the appropriate Medical Authority, to this Ministry within 01 week. However, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) has neither furnished his medical records nor reported to the Govt. of Arunachal Pradesh till date.
- 7. AND WHEREAS, para 8(vi)(b) of the Guidelines for Transfer/Posting of IAS/IPS officers of AGMUT cadre, 2016 stipulates that officers belonging to DANICS/DANIPS/SCS/SPS shall, immediately after induction to the IAS/IPS, be liable for posting outside the segments from where they are inducted. Further, para 9(viii) of these Guidelines stipulates that officers under transfer shall be relieved to join their new segment within 15 days from the effective date of transfer. Should non-compliance of transfer orders persist, the officer would be liable to incur several consequences under the service rules, such as stoppage of salary, issuance of displeasure, debarment from promotion/Central Deputation etc. The onus of joining a segment will lie on the officer. Para 10(iv) of the Guidelines also stipulates that transfer orders once issued will be strictly enforced, and disciplinary proceedings would be initiated against officers who bring extraneous pressure for cancellation of transfer orders.
- 8. AND WHEREAS, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) has failed to report to the Govt. of Arunachal Pradesh even after the expiry of more than 07 months from issuance of transfer order dated 13.12.2024 and more than 06 months after being relieved from the Delhi Police. The officer has claimed to be under medical rest during the intervening period; however, he has neither submitted any medical document to substantiate his claim of being unfit to report to the Govt. of Arunachal Pradesh nor has he clarified the nature or prognosis of his illness till date.
- 9. AND WHEREAS, the Competent Authority in the Ministry of Home Affairs has come to the provisional conclusion that by his aforesaid acts of gross misconduct, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) has failed to maintain absolute professionalism, discipline, and devotion in the discharge of his duties and also committed acts that are contrary to the laws, service rules, and regulations thus exhibiting behavior that is unbecoming of a Govt. servant, in violation of several provisions of Rule 3 of the All India Services (Conduct) Rules, 1968.

- 10. AND NOW, THEREFORE, Dr. G Ramgopal Naik, IPS (AGMUT: 2017) is hereby directed to show cause within 15 days from the date of receipt of this Memorandum as to why disciplinary proceedings should not be initiated against him for the aforesaid acts of misconduct. If no reply is received within the stipulated timeframe, it shall be presumed that the officer has nothing to submit and action as deemed fit will be taken as per law.
- 11. This issues with the approval of the competent authority.

In the light of the above submissions, it is humbly requested that the disciplinary proceedings may kindly be dropped and MHA Memorandum dated 03/07/2025 may kindly be filed and my case be reconsidered in the light of the humanitarian considerations and judicial precedents, as the undersigned has already been undergoing lot of mental stress and agony causing affect on my health.
